This office has reviewed the submissions as per MORT&H & Contract provisions, the Chemical Admixture (*for use in Structural Concrete and PQC work as per 1012.3 & 602.2.3 of MORT&H Specifications*), Curing Compound (*as per clause 601.6.7 (b) & 602.9.12.2 of the MORT&H Specifications*) & Joint Sealing Compound (*602.2.10 of the MORT&H Specifications*) can be procured from **M/s. Supreme Bituchem India Pvt. Ltd**, subject to fulfilment of followings:

Chemical Admixtures:

1. Third Party Test Reports, confirming IS: 9103, it is requested to arrange third party testing (confirming with IS: 9103 & IS: 6925) at the earliest.
2. The Concessionaire shall ensure to collect manufacture's test certificates, confirming to IS: 9103 & IS: 6925 shall be collected for each supply and shall be available in Laboratory.
3. As per clause 1012.2.3.1 of the MORT&H Specifications, provide information concerning each supply obtaining from **M/s. Supreme Bituchem India Pvt. Ltd**.
4. The Concessionaire shall ensure adequate storage of Chemical Admixture as specified by **M/s. Supreme Bituchem India Pvt. Ltd**.

Curing Compound:

1. Manufacture's test results confirming with ASTM C-309-8, Type-2. It is requested to submit manufacturer's test results as per BS-7542 & arrange third party testing confirming with BS-7542 & ASTM C-309-8 Type-2 at the earliest. Availability of MTC for each supply shall be insured in Laboratory.

2. The Concessionaire shall ensure adequate storage of Joint Sealing Compound as specified by the **M/s. Supreme Bituchem India Pvt. Ltd.**
3. Application of curing compound shall be as per clause 601.6.7 & 602.9.12 of the MORT&H specifications.
4. As per clause 602.9.12 of the MORT&H Specifications, in PQC work, the curing compound shall not react chemically with the concrete and the film / membranes shall not crack, peel or disintegrate within three weeks of application.

Sealant:

1. Submit Manufacture's test results confirming with IS: 11433 (Part-1) BS: 5212 (Part-II), and arrange third party testing (confirming with IS: 11433 (Part-1) BS: 5212 (Part-II)) at the earliest.
2. The Concessionaire shall ensure to collect manufacture's test certificates, confirming to IS: 11433 (Part-1) BS: 5212 (Part-II), for each supply and shall be available in Laboratory.
3. The Concessionaire shall ensure adequate storage of Joint Sealing Compound as specified by the **M/s. Supreme Bituchem India Pvt. Ltd.**
4. As per clause 602.210 of the MORTH Specifications, the concessionaire shall establish that the sealant is not more than 6 month old for use in PQC work.

This is being forwarded for necessary action pursuant to clause 118 of the MORT&H Specification.
